












As part of SII 55th anniversary, we are pleased to bring you an interview with Past President William Goh who served for two terms as SII President in the 1970s. SII was then known as IIS.

SII: PP William, please share with us your journey in the insurance industry.

PP William: I was offered a teaching job when Prudential called me for an interview. At the interview, I was asked to write a one-page essay on insurance. I had the foresight to read up on insurance before I went for the interview. I got the job on the spot! (Learning lesson for job aspirants: read up on the industry you are going to join). With two job offers in hand, I asked my favourite school teacher for advice. He said, "Take the insurance job." The rest is history.

SII: What contributed to your progress in the insurance industry?

PP William: Acquiring the appropriate insurance qualification was key to my progress in my insurance career. In those days, there were about a dozen ACIIs in Singapore. We were highly valued and respected by the insurance employers. We were roped in as part-time lecturers for the Singapore Insurance Training Centre (SITC) to prepare insurance employees for the CII examinations. There was an urgent need to augment the pool of qualified insurance practitioners.

SII: Please tell us something about your transition from insurance practice to insurance education and training?

PP William: I started my insurance career working for general and life insurance companies and insurance and reinsurance brokers. Prudential was my best starting point. I joined their General Insurance Division. Being a British insurer they naturally encouraged me to pursue the CII examinations. I was rewarded for successes in the examinations.

My transition to insurance education and training was unplanned. In 1984, the Skills Development Fund invited SITC to nominate a "Centre Director" to represent the insurance industry to undergo a full-time half year training management diploma course in London. SDF also invited other industries like banking, hospitality, construction etc to do likewise. Their funding was 90%. The objective was to ensure that the industries in future could design and conduct "structured" courses (not ad hoc as in the past). SITC engaged me as a Director of Studies and I was sent to London. I returned with a Diploma in Training Management. SITC later changed its name to Singapore Insurance Institute (now known as Singapore College of Insurance). I retired as Executive Director.

SII: What is your impression of the Singapore Insurance Institute and the role it plays?

PP William: The Institute has a more professional image today. Its members are mainly qualified insurance practitioners. In the early days, anyone in the insurance industry could join as members. The membership then was more than 1,000. There were more sports and social activities. Today, there are more professional activities. It plays a vital role in upgrading the knowledge and skills of the insurance workforce. Through courses, workshops, seminars and conferences, SII provides an excellent platform for people in the insurance industry to network and enhance their careers.

SII: How do you envision the insurance industry in 10 years' time?


PP William: Competition for the insurance pie will remain as keen as ever. Even keener is the competition for good staff. Are insurance employers doing enough to attract and retain their qualified staff? It's not just the dollars that keep good staff. To me it's just one word: RELATIONSHIPS. A sense of belonging. For example, does the CEO interact with his employees? Is his door open? Are opportunities available for staff at all levels to advance their careers?

SII: In a sentence, please describe yourself.

PP William: I am focused on what I do and I am approachable to those who need a listening ear.
